PORTFOLIO OBJECTIVES AND STRATEGY

The Wise Ethical Growth Model Portfolio is designed for clients who are looking for a total return in line with the MSCI PIMFA Growth index over a 5 to 10-year period. We aim to achieve this by exclusively investing in a focussed list of ethical and sustainability-oriented funds (unit trusts, investment trusts and OEICs). These funds will have specific objectives of providing capital to businesses whose operations and activities either meet specific ethical standards or are engaged in improving the long-term sustainability of the earth's resources. The portfolio will have diversification across geography, asset class and investment style. The funds invest in real assets, such as company shares (listed both in the UK and overseas), property, fixed interest and cash. The Portfolio invests 60-100% in 'medium' risk assets, such as shares and property and can include up to 20% in 'high' risk assets such as shares in specific countries and industries. The Portfolio can also invest up to 40% in 'lower' or 'minimal' risk assets such as higher quality company debt and cash. We therefore consider the portfolio to be suitable for those willing to adopt a medium risk profile.

MONTHLY COMMENTARY

March was a tough month for investors across the board.

While we have seen some rather dramatic tariff moves already in April, at the time of writing, March did see escalating threats of tariffs from the Trump administration already begin to weigh heavily on global markets, with US businesses set to see a substantial rise in the cost of imported goods, as well as potentially impacted by any reciprocal tariffs. This resulted in a drawdown in global equity market drawdown of around 7% led by the US market, down over 8% in sterling terms.

Europe was down 3%, susceptible to tariff difficulties being a net exporter to the US, similar with Japan down just over 2%, while the UK market was down just 2% being less reliant on US exports and holding a trade deficit. Emerging markets were down a bit shy of 2% with some markets like India being relatively unaffected by tariff escalation, while China and much of south east Asia are very much within the president's crosshairs.

Bonds also suffered in March with long term yields drifting up along with credit spreads widening. UK Gilts and corporate bonds on the whole were down just over 1%, while high yield, which tends to be shorter dated bonds, were less affected by the rise in rates, and were down a bit less than 1%.

Property, being fairly insulated from tariffs and global trade saw a decent month, up around 0.4% for both direct and liquid listed UK property.

The Ethical Growth model returned -5.26%, behind the -4.32% return for the benchmark (PIMFA Growth).

The Global equity exposure performed poorly off the back of concerns over US tariffs and global trade with the Vanguard ESG Developed world all cap equity index fund and the Fundsmith Sustainable Equity fund returning -8%. Our UK exposure, despite the UK market broadly holding up better, did poorly with the Aegon Ethical fund down -5%, an area still under review. The AB International Healthcare fund also had a tough month, returning -4.8%.

We made no changes to the portfolio in March and continue to favour a strategy of strong core global equity exposure via the low fee passive Vanguard ESG Developed World All Cap Equity Index fund as well as the Fundsmith Sustainable Equity fund. This more volatile exposure is moderated by high quality bonds in the fixed income portion of the portfolio.

Tactically, we maintain our position in the Aegon Ethical Equity fund to capture the substantial discount we see in the UK market along with an additional small position in the Castlefield Sustainable UK Smaller Companies fund to take advantage of the further discount in UK small caps. We also maintain a 5% position in the AB International Healthcare fund to take advantage of the attractive valuations in the healthcare sector – a sector that also has enjoyed strong long-term returns due to the high-quality nature of many healthcare businesses and the steady secular growth trends they are exposed to (e.g. aging populations).

Another theme we have recently invested in is in the Regnan Water and waste fund, allowing us to invest in a relatively underappreciated global trend towards urbanisation and improved communal hygiene. Stocks here, while not glamorous, offer decent growth and favourable valuations compared to other growth trends such as those within technology like AI


We also have a modest 5% position in Schroder Global Cities Real Estate fund as we continue to see value in this down beaten asset class as shown by the depressed prices in commercial properties and large net asset value discounts in listed real estate trusts.


